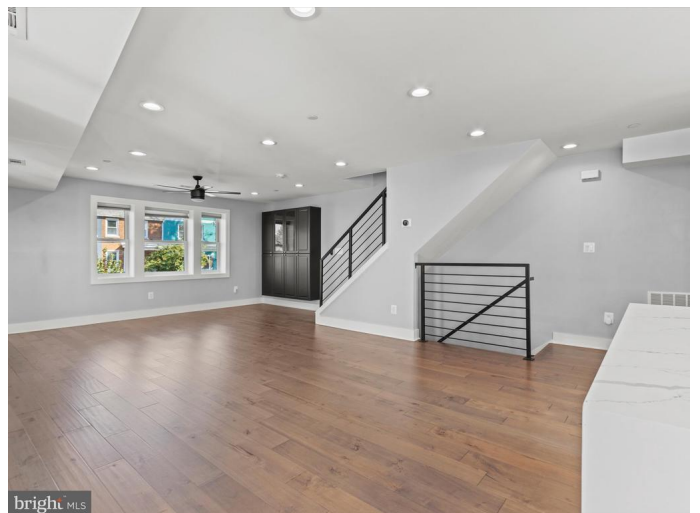

Penthouse vantage meets city glamour in this two-level 2BR/2.5BA light-filled condo. Renovated from top to bottom in 2020. Crowned by 500-SF private roof terrace, take in the unbeatable cinematic views of the Capitol, the Monument, and the DC skyline. Inside, gallery-scaled living unfolds across an open plan with tall ceilings, wide-plank hardwoods, and windows on three exposures. The chef's kitchen reads sleek and urban—quartz waterfall island, full stainless suite, custom pantry cabinetry—and opens via a wide slider to a balcony for morning coffee or evening aperitifs. Upstairs, two quiet bedrooms include a hotel-caliber primary suite with a fitted walk-in closet and a spa bath featuring an oversized, quartz-clad shower with stone floor, generous vanity, and a daylighting window. Smart, efficient systems, ceiling fans, abundant storage, and a fenced front garden underscore easy ownership, while dedicated off-street parking conveys. The address delivers true city convenience: moments to Red Line service at NoMa—Gallaudet U; the H Street streetcar direct to Union Station for Amtrak/MARC/VRE; frequent Metrobus service; neighborhood bike lanes with Capital Bikeshare close by; and fast connections to New York Ave/US-50, I-395, and Route 1. Whole Foods, Trader Joe's, Union Market, destination dining, cafés, fitness studios, and the National Arboretum are all within easy reach—an elevated urban retreat with a rooftop made for skyline nights.
